

Santacruz Silver Shares to Resume Trading on June 16, 2023

Vancouver, B.C. – Santacruz Silver Mining Ltd. (TSX.V:SCZ) ("Santacruz" or "the Company") reports that following the cease trade order being lifted by the British Columbia Securities Commission and the Ontario Securities Commission on Friday June 9, 2023, its shares will resume trading on Friday June 16, 2023, on the TSX Venture Exchange when the market opens.

Santacruz Silver is engaged in the operation, acquisition, exploration, and development of mineral properties in Latin America.
